# Shevington Parish Council Clerk's Report to the Meeting of the Council – 28 February 2024

## Storm Pia Tree Damage

The treeworks arranged to deal with the aftermath of Storm Pia in the Memorial Garden have been carried out. The original price quoted and approved by the Council did not include stump grinding. This was because of the uncertainty surrounding the root from the large oak tree and whether and how much of it would fall back into the hole created when the tree was uprooted. In the end it did not fall back in, so the stump grinding became a much bigger job.

The quote of £450 from Stumpbusters for stump grinding the very large root and stump and the two smaller ones in the Memorial Garden was approved under delegated authority. The price quoted also included the grinding of the two stumps remaining from the decayed wood carvings further up the park. The total for the work came to less than the quotes provided by the other contractors. Had the large root fallen back into the hole, all the stumps would have been quite small and the cost of stump grinding would have been significantly less.

# M&Y, Miles Lane Development & Crooke Village Projects

The project manager for the Extra Care development at Miles Lane has replied to our invitation to attend a meeting of the Parish Council to provide another update. He has agreed to try to make arrangements for M&Y's site manager to attend as well. I have provided him with suggested dates and am awaiting his reply. The invitation included a chaser with regard to help from M&Y for Crooke Village projects. M&Y are dealing with the CVRA directly.

#### Voluntary Work Carried out by Members of Shevington Village Bowling Green

Work on the painting of the Bowling Club pavilion has begun, but has not yet been completed. Three sessions have so far been held with pupils of Millbrook Community Primary School so that they could work on the artwork. More are planned after the half term break.

#### **Potholes in Forest Fold**

The potholes in the roadway at Forest Fold were repaired in the final months of 2023.

## **New Shed for Raised Bed Allotments**

Research into suitable sheds and their fitting is currently being carried out.
